CalAIM is the Department of Health Care Services (DHCS) multi-year initiative to improve outcomes in Medi-Cal through delivery systems reforms including upcoming waiver renewals.

- DHCS concept paper has now been published and available
- 10/29 Stakeholder Advisory Committee meetings: The Department started its public stakeholder dialogue on the CalAIM proposals on October 29, during meetings of the Behavioral Health Stakeholder
